Continuing Participation, Acceptance of Risk, Release and Waiver Agreement

In consideration of my participation in the continuing Marked Men For Christ experience, I hereby accept responsibility for my safety and agree to release and discharge Marked Men for Christ, Inc., a Colorado non-profit corporation, it's agents, officers, directors, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereafter collectively referred to as "MMFC") on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate of, as follows:

I acknowledge that the participation in my continuing spiritual growth and development experiences involves known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself; to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risks include, among other things, strenuous and vigorous physical, mental, emotional, and intellectual activity such as outdoor and indoor activities during day or night; the possibility of slips and falls, bruises, sprains, lacerations, fractures, concussions, or even more life threatening hazards, even death. During an activity there may be contact with plants, animals, or insects that could create hazards such as stings, allergies, and assorted diseases. Furthermore, MMFC instructors have difficult jobs to perform. They seek safety, but are not infallible. They might be ignorant of a participant's fitness or abilities. They might misjudge the weather, the elements, or the terrain. They may give inadequate warnings or instructions, and the equipment being used might malfunction.

I expressly agree, promise and do accept and assume all of the risks existing in my continuing participation in MMFC activities. My participation in these activities is purely voluntary, and I elect to participate in spite of the risks.

I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless MMFC from any and all claims, demands, or causes of action, which are in any way connected to my participation in MMFC activities or my use of MMFC's equipment or facilities, including any such claims which allege negligent acts or omissions of MMFC.

Should MMFC, or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating; or else I agree to bear the costs of such injury or damage to myself. I further certify that I have no medical or physical conditions which could interfere with my safety in these activities, or else I am willing to assume - and bear the costs of - all risks that may be created, directly or indirectly by any such condition. I may at any time voluntarily choose not to participate in certain activities due to physical or non-physical limitations to avoid injury.

I hereby agree to submit all controversies, claims and matters of difference to arbitration in Denver, Colorado, before the Judicial Arbiter Group, Inc. I further agree that the substantive law of Colorado shall apply in that action without regard to the conflict of law rules of Colorado. Proceedings shall be

conducted in accordance with the Colorado Rules of Civil Procedure and Rules of Evidence, except as modified by agreement of the parties and order of the arbiter. This submission and agreement to arbitrate shall be specifically enforceable.

I further agree Arbitration may proceed in the absence of any party if notice of the proceedings has been given to such party. The parties agree to abide by all awards rendered in such proceedings. Any award shall be accompanied by findings of fact and conclusions of law and may be enforced through the entry of judgment or issuance of execution in any Colorado court having jurisdiction. No party shall be considered in default hereunder during the pendency of arbitration proceedings relating to such default.

By signing this document, I acknowledge that if anyone is hurt or property damaged during my participation in these activities, I may be found by a court of law to have waived my right to maintain a legal proceeding against MMFC on the basis of any claim from which I have released them as described above. I have had sufficient opportunity to read this entire document, I have read and understood it, and agree to be bound by its terms for all MMFC activities in which I participate, now and in the future.

Confidentiality and Responsibility Agreement
